

Tom is now helping more at home with the continued work there but is still close at hand when needed for tasks at the office or at events when he is needed. Again, we thank Tom for 21+ years of service and support every step of the way!

We want to also thank those who gave financially to keep us afloat. We continued to rely heavily on our Alberta Civil Society Fund grant that has carried us longer than anticipated. More to say regarding our grant so we will leave that for our Treasures Report.

Now onward, with our 2023 - 2024 Fiscal Year's activities!

Summer 2023



Since a new staff member was proving difficult to fill, we came across a summer student who was home in High River for the summer. Timothy Rugg (TJ), a 3rd year U of A honours computer science student started employment the beginning of May and carried throughout his summer break. TJ was a whiz on the computer developing two online donation management systems designed to streamline and enhance assistance for those affected by a disaster,



'Alberta Recovers' and 'Crosswalk', to assist those who have everyday challenges. These two programs were already in the works, but TJ put the necessary programming in place to make them functional. Our Faith Emergency Preparedness Initiative (FEPI) on-line form was also reformatted for a greater level of effectiveness. In order to know how to

carry on with the programs once TJ left his position, an Operation's Manual was developed for IT protocol as well as information for banking, insurance, policy & procedures manual; all information very beneficial for moving forward.



The close of August a new staff member, Michael Lum, was hired as Executive Director's Associate. Michael was a senior pastor at the High River Alliance Church for 15 months before joining us, September 11. Michael was with us just a short time before it became evident that he was not the best fit for this position. Later in September, he shared that working with BofL was not something he wished to do long term. He offered to step out of his position, if we wanted to find someone who was better suited. This did indeed come as a surprise but knowing that he was not interested in working long term, it made the decision to accept his resignation a little easier, but it was still a disappointment!

Alberta NGO Partner

We were very pleased to be accepted as an Alberta NGO partner at their Face-to-Face meeting last September. The Alberta NGO Council is a network of non-governmental organizations that are active participants in Alberta's Emergency Management landscape. The purpose of the Alberta NGO Council is to support municipal and provincial emergency planning and preparedness, response and recovery efforts through coordination, cooperation, collaboration, and communication.

We have monthly virtual meetings and one Face-to-Face gathering with the partners. The meeting in 2023 was held at Samaritan's Purse facility in Calgary. Bridges of Love has taken on the Treasurers position as members so members can give as they can.

20th Anniversary Celebration, October 12, 2023



Since our AGM was scheduled for the month of October, a decision was made to combine this meeting with a celebration for Bridges of Love's 20 Anniversary, with a theme, "We Are One". Heritage Inn, HR proved to be a lovely venue for an October 12 luncheon. Invitations were mailed (20) and an additional 25 were emailed to those who have been supporters or someway connected with

the ministry. Wayne Cao, retired Calgary MLA, was invited as our special guest speaker who shared our involvement with the flood relief efforts in Calgary. Wayne was responsible for BofL's Hero's of the Flood awards in 2014. Michael Lum sang, Brian Doerksen's song, "We are One" on closing our celebration along with a video with special memories since the beginning of Bridges of Love Ministry. 20 guests were invited back to our office for apple pie, so we enjoyed an additional visit with those who came from out of town. What a fantastic closing to 20 years serving through this ministry! Thank you to all who attended.



Civil Society Fund

The end of September, the 3rd reporting period for the CSF grant was completed. The grant completion date was March 24, 2024, but due to the three-month delay in receiving the funds, the deadline was extended to the end of June. Then due to our move to Red Deer, the end date was again extended to the close of 2024. The extension allowed revisions to our budget since extra funds were available from the staff line to allocate to areas that needed a boost in support (Marketing & Communication). All in all, the grant experience has been positive, with appreciation to the past Minister of Social Service, Jason Luan and present Minister of Seniors, Community and Social Services, Jason Nixon along with the CSF Team. We were hesitant to take Government Funds but this new experience has been positive to date. From the start, Bridges of Love has followed and believed that support should not come from Lottery Funds, so this an area we questioned before accepting the Alberta Civil Society grant. Alberta grants are traditionally funded by the Lottery resources generated, so there are not many grants that are available in this province which is unfortunate. We had a meeting with Jason Nixon and he shared this was something the government was working on to change, so that was encouraging to hear!

Seven County's Church Connections and Survey

With affirmation from the Civil Society Fund that our grant had been designated as a Regional and not Provincial Grant, they suggested we select the specific regions we wished to share our programs. Seven counties from Vulcan to Kneehill were selected so this made our task manageable and attainable. Databases for these counties was developed with contact information for each church documented. The seven county churches were now included in our monthly Newsletters introducing our programs. After a few months, a survey was shared to help identify the churches understanding and acceptance. These results were tabulated to identify the success and impact from multiply phone calls, emails, and Newsletters. The results indicated that our greatest support came from Mountain View County, probably due to Michael's connections to this region, so our decision to have our next CERT Summit in this county was made.

• Mountain View County CERT Summit, February 9, 10, & 17

Prior to the Summit, over three months, three road trips were made to Mountain View County (MVC) with a goal of building trust and support for a CERT training session in the New Year. Mid November, churches in Carstairs (Rock Church), Sundre (McDougal Chapel), First Baptist Church (Olds) Zion & Mountain View EM Church (Didsbury) and dropped off posters and brochures in other locations as well. We felt there was a positive response from the pastors we spoke with so we were encouraged there would be support coming from the MVC church community. While in Olds, possible venues were visited, and a decision was made to hold the Summit in the Olds Evergreen & District Centre. Being a large facility it had plenty of room for the Friday evening session.

In January we made our last trip to make as many connections as possible before the Summit which was scheduled for Feb. 9, 10, and 17. This trip was focused more on the community at large with schools, town offices, grocery stores, insurance companies receiving posters and brochures. Again, it was a great introduction to many localities (Carstairs, Cremona, Sundre, Olds, Didsbury, Bergon) with interest shown by many along the way. We also had a meeting with the Municipal Emergency Manager, Ryan Morrison who was very nice and welcoming.

Not only were we sharing the CERT training opportunity but also invited community members to attend the Friday evening Key-note presentation by Laura Stewart who was invited to share the Fire Smart program. Laura is a wildfire specialist who lives in Edmonton, and she kindly consented to do our presentation. With a dry winter with an increase in wildfire activity predicted, we felt this was a perfect topic for this time of the year when people should be preparing for such an occurrence.

> CERT Summit Marketing

As mentioned, much territory was covered face-to-face making introductions to our CERT training and Friday evening Key-note topic. Besides sharing our brochures and posters, we placed an ad in the Albertan Paper in Olds, had an ad for four days on the Olds Radio Station and 96.5 CKFM Olds did an interview the Monday before the event. Judy Dahl, the Olds Mayor was invited to bring greetings from the town and introduce our Key-note Speaker. Ryan Morrison, Municipal EM was invited but he declined due to a ski trip at that time.

CERT Summit Instructors

The hope for this out-of-town Summit was to invite professionals from their county to do the instructing. By having trainers in their own locality, it would be beneficial for future training events. Judy McMillan once again agreed to team teach a CERT Train-the-Trainer event in Olds but after advertising for a few months, we did get a response to carry on with the training.

Randy Smith, our Fire Safety instructor who retired to Olds took on this module as well as Search and Rescue. SGT. Eyvi Smith, our Terrorism instructor, also agreed to take on the Terrorism module and we were fortunate to meet a Social Worker at the Calgary Networking luncheon, Santuzza Wolff who was interested in doing the Psychology of Trauma training. After reviewing, the material, she accepted the invitation to join our team of instructors.

The Disaster Medical Operations module was taught by an Olds Operating Nurse who we met at St. Stephen's Catholic Church and Tara turned out to be an amazing instructor! She not only taught but attended the CERT Summit so is now a graduate who has offered to do more training sessions down the road.

CERT organization module and the Disaster Preparedness modules were done by yours truly with Tom assisting with technical requirements. He and Cam Nikitiuk (CERT Grad) helped with set up and take down. Everything went very well with great evaluation results for each of our instructors. We appreciated the Mayor of Olds, Judy Dahl who introduced the Friday evening session, with Laura Stewart, FireSmart specialist, sharing a wonderful presentation. The turnout could have been better, but it was our first training session held away from our office, so it was a learning experience for future events. Building trusting relationships from leaders in the communities in these 7 counties is key to greater support and success.



Awards and Supporting Articles

The past year, Bridges of Love received some welcomed support and affirmation. The Calgary Guardian did a very nice interview for their paper that can still be accessed at this <u>link</u>. Also, recognition from Direct Energy was received as runner up as their choice for <u>Volunteer Citizen of the Year</u>. This honour came with a \$500 donation to the charity of choice, so Bridges of Love received this monetary gift. The High River Times also picked up on the award and did a follow-up for their Friday October 27 paper.

April brought additional great news when we received the Canadian Interagency Forest Fire Centre Inc. FireSmart Canada Wildfire Community Preparedness Day Promotion award. \$500 plus resources were donated to BofL to promote Wildfire Preparedness during Emergency Preparedness Week. We gained exposure through these newspaper and magazine articles, and awards.

Marketing Service

Due to not finding a staff member to help with our marketing, a service, "Virtual Gurus" was recommended as a resource for Social Media Marketing. The person we were partnered with was from Texas, so the fit was not ideal. We stayed with the program for only a short time, however, as we did not see the results we were hoping for or that justified the cost of the service.

Newer Office Furnishings

With the unused budget still available before the end of our grant, a decision was made to purchase newer office chairs, tables (including a Board table), and a commercial printer. This decision was made before the move was anticipated but we are sure God had this in the works for our new office in Red Deer. Our folding chairs were not adequate for heavier set individuals, as they were being damaged so unusable. We purchased studier folding chairs from a Calgary company and a newer commercial printer from Alberta Cartridge & Toner, longtime friends and supporters who gave us a good price.

Emergency Preparedness Week, May 11, 2024



We were pleased to receive another invitation from Garth Misura (Okotoks Emergency Manager) to attend their Emergency Preparedness Week activity on May 11. We appreciated Cam Nikitiuk, CERT Grad coming to help out. The FireSmart resources were a focal point so a good opportunity to support and bring awareness for the importance of wildfire preparedness. Since Cam helped man the booth, Tom stayed in High River to begin packing up our office for the pending move to Red Deer.



March Special Board Meeting

A Special Meeting was called March 26, to discuss Relocation of Bridges of Love to Red Deer, AB. Reasons for this were two-fold: 1. Support for our CERT training in Foothills County had been minimal since our move five years ago to High River, and 2. The CSF grant territory covers Central Alberta, which was felt Red Deer to be a better location for Bridges of Love's future.

Together with personal reasons associated with our mortgage coming due, we felt this was the time to make the move with a strong selling market. Much prayer from Tom, myself, and our Board of Director's was put into this decision and from the quick sell of our condo, things came together at lightning speed confirming our decision.

After settling into our apartment, we began the search for Bridges of Love's Central Alberta location. The search was not too time-consuming, however, as there were few facilities for lease in our price range. The building we rented until the end of 2024 is in the lower level of Roll'n Oilfield Industries building in the downtown core. It has potential, and the price was right, with no triple net included, which made it affordable.

The second space, which is still vacant, would be ideal for training and as a large meeting room. With rent set at \$500/month we will continue to pray for God's provisions to secure this additional space. As you can see from the photo, our storage room is full to overflowing, so it would be great to have this additional space to utilize the office furnishings for training, meetings, etc. The rental agreement includes that we be given the first "right of refusal" for this 600 sq. ft. space. In the meantime, we are settled and happy with our new office space.

BRIDGES OF LOVE MINISTRY'S FINANCIALS ANNUAL GENERAL MEETING, July 31, 2023 – August 1, 2024

Please see Financial Reports included.

Bridges of Love's past fiscal year continues to rely heavily on the Civil Society Fund (CSF) grant for our financial support. As mentioned previously in our ED Report, the funds were late in arriving, so the government gave us a three-month extension to the close of June, 2024. Then, due to our move to Red Deer, we were given another extension to the close of 2024 along with a change in our proposed budget. Please see our final approved budget which will remain constant for the remainder of our grant period.

We continue to use Lorac Management as our accounting firm and even though we are now separated by distance, we have managed to keep the books up-to-date and checked periodically. Carol is great to assist when needed and she is very familiar with our financials, so I feel it is easiest to keep them as our accountant until the grant is completed. We can decide if we wish to switch to a Red Deer firm when the time comes.

Carol deferred \$50,000 on the books for our Fiscal year end so we would not have a large Net Income Balance.

The Income Tax, GST, and Society Regulations have been completed for our Fiscal year.

Private donations have been minimal again, so we are becoming a little more aggressive for our 'ask' in our monthly Newsletter. Since moving to our Red Deer office, we have made several pleas for funds to secure room 102 across the hall from our present office space. This 600 sq. ft. room will allow for larger gatherings, CERT training, and any other activities where we need additional room. Our storage room is over-loaded which makes it difficult to find anything when needed!

Since Michael Lum's employment time was cut short, we had a surplus in our staff budget line. The excess was transferred to Supplies, Promotion/Marketing, and Rent. Sufficient funds were left in the Staff budget to hire a replacement at \$30/hr. We did have a very short hire, Janet Ducommun, who was with us for a week on Contract and Virtual Guru were given a try for a month.

We made the decision to not hire another team member until we relocated to Red Deer. As soon as we were settled, an Operations & Technical Support Specialist position was posted. We had five resumes submitted, with Felicia Smith hired on July 9, 2024, with a starting date set for August 5. Felicia and her family were moving from Fort St. John, so they needed time to find a home and get settled before starting a new position with Bridges of Love. The salary offered was accepted so we kept within the budget set for the job. Since we had only five months left before year end, we kept the position as Contract until we have funding in place in 2025 to offer a Staff position.

With all the activities moving personally May 1 and then relocating our office June 5, we have not had much time to apply for grants. One larger grant with the McLean Foundation was started before year end and was submitted on September 11. The time frame for a reply is eight weeks so we are hopeful to receive some of the \$40,000 that was requested.

Our larger expenses have included the new to us tables, chairs (17), desk chairs (3), and a used commercial printer from Alberta Cartridge and Toner with 4 new cartridges. This purchase was made before we made the decision to move but we were happy to have the new furnishings which will serve us well for years to come. Since our office did not have water in our space (have to wash dishes in the washroom), we purchased a used water dispenser that gives hot and cold water. We enjoyed the machine while it lasted but unfortunately, it sprung a leak, so we had to shut it down. If we have extra funds down the road, it would be nice to get another machine, a new one this time!

The Mountain View County CERT Summit held in Olds went well but due to the low turnout, it did cost us to put on the event. The travel expenditures for three trips back and forth to the county with a few over-night stays were responsible for the travel, meals, and fuel expenses. We also had rental of the Senior's venue and the usual marketing/promotion/advertising expenses that come from putting on the event.

Unfortunately, our CERT Affiliate partner, Bob Davies, RMD Safety Ltd. Did not pay their Affiliate Membership Fee (\$500) in the New Year. He has been contacted many times to inquire to his intentions, with no response. I would assume he is no longer interested in taking this role, but that means he does not use or share our CERT resources and training materials. We hope he will abide by what he committed to and signed a contract for!

Our MBNA Credit Card is used for most purchases and the balance is cleared completely each month, so no interest is paid.

We appreciated the Board approval for \$6000 salary to be taken by Marg for the months (3) we did not have a staff member. These funds covered the two moves which made the relocation possible. Thank you, Board!

As of September 23, when this report was written, we have \$35,281.85 in our Servus Credit Union Savings Account, \$4641.39 in our Community Account, and \$3027.02 in our Bridges of Love Bank of Nova Scotia Account. We are well situated until the end of this calendar year.

SUMMARY

We are very thankful that our financials are in-line with the funds allotted from the CSF. It has been such a gift to have the funds to carry on for almost 3 years without too much concern. All good things must come to an end, however, so we now must be diligent in seeking funding for the year ahead.

As we look back over the past 21 years, God has provided for our needs every step of the way. We may not have the biggest or the best, but we have all that we need to accomplish the work that He has given us to do. For that we remain thankful and blessed!
